PACER LOGO DESIGN GUIDELINES

Pacer logos are to be used in compliance with our [Standards Manual](#), summarized below.

Do:

- Always include the statement "Pacer International service marks used by permission" in 5-point type or at the bottom of each page that includes a reference to Pacer or includes the Pacer corporate logo elements.
- Provide a minimum of ½ inch clear space around the logo.
- Use only the high-resolution electronic artwork provided by Pacer.

Do not:

- Do not alter the size or position of the corporate logo elements in relation to each other.
- Do not alter location or placement of the corporate logo elements in relation to each other.
- Do not rotate corporate logo elements, modify colors, add animation, or introduce other graphic elements.
- Do not place the corporate logo elements in a sentence as a replacement for a word.
- Do not place the corporate logo elements on busy or distracting backgrounds.
- Do not scale the corporate logo elements smaller than ½ inch.

What logo options are available for use?

Pacer offers the following three logo options. A full color and a one-color version of each are available, as are versions without the tagline:

- 1) Corporate logo
- 2) Pacer/OWL co-branded logo
- 3) Pacer/RFI co-branded logo

How do I get permission to use the Pacer logo?

See our Pacer Logo Use Request, and use the watermarked low-resolution [Pacer Logo Options](#) provided, prepare a layout of your design showing how our logo will be featured within your material, and submit your layout to us for approval. Upon Pacer's approval, you will receive a high-resolution logo to be used in the approved layout.

When would a request be denied?

A request may be denied for one of the following reasons:

- 1) Requested usage does not comply with the Pacer Logo Use Request instructions or Pacer Logo Design Guidelines
- 2) Requested usage seeks an endorsement for Pacer
- 3) Requested usage does not reflect accurately or positively on Pacer

What should I do if my request is denied?

You can always change your design and resubmit a new request that meets our Pacer Logo Use Request instructions and Pacer Logo Design Guidelines.

How long will it take to receive a response to my request to use the Pacer logo?

Pacer endeavors to turn-around requests within 72 hours.

What if I make changes to my request after I receive approval?

If your layout and/or content changes at any time for whatever reason, you must resubmit the design for review and approval.
